REQUIREMENTS TO BECOME A VENDOR

ALL VENDORS OPERATE UNDER THE FLEA MARKET'S OCCUPATIONAL LICENSE SO THEIR OWN IS NOT NECESSARY

TYPICAL VENDOR:

- MUST HAVE FL SALES TAX ID NUMBER (NOT A BUSINESS LICENSE)
- 1ST MONTHS FULL RENT (CASH OR CARD FOR 1ST PAYMENT) WE ACCEPT CHECKS AFTER 1ST MONTH
- COPY OF VALID ID
- FILL OUT VENDOR FORM
- SIGN COPY OF RULES AND REGULATIONS

FOOD OR CONCESSION VENDOR

- ALL ABOVE PLUS THE REQUIREMENTS FOR CONCESSION FORM.
- IF IT IS A SPACE THAT IS ABLE TO SELL BEER, VENDOR IS REQUIRED TO PROVIDE THEIR OWN BEER LICENSE (MUST GO TO COUNTY BLDG ON LITTLE RD. AND APPLY FOR LICENSE) THERE ARE ONLY 4 SPACES ALLOWED TO HAVE BEER SERVED AT THIS LOCATION

BAKED OR COOKED FOOD FROM HOME

- THIS FALLS UNDER THE COTTAGE FOOD ACT, THE REQUIREMENTS ARE AS FOLLOWS:
 - ALL PAPERWORK AS A TYPICAL VENDOR
 - FOOD PRODUCT MUST BE WRAPPED CORRECTLY AND LABELLED WITH ALL INGREDIENTS LISTED

LIVE PLANT SALES

- ALL PAPERWORK OF A TYPICAL VENDOR
- NURSERY STOCK LICENSE FROM FLORIDA DEPT. OF AGRICULTURE
- CURRENT INSPECTION FROM THE DEPT. OF AGR.

OUTDOOR MARKET (WEATHER PERMITTING)

- THIS IS HELD EVERY OTHER WEEKEND IN THE NORTH AREA FIELDS ON SAT. AND SUN.
- PRICE PER TABLE IS \$5.00 OR \$15 PER TABLE FOR DEALERS OR NEW ITEMS (IF IN BOX OR WRAPPER, IT IS NEW) AND FREE FOR INDOOR VENDORS
- NO SALES TAX ID NUMBER IS NECESSARY
- NO FOOD OR DRINK CAN BE SOLD

ITEMS EXCLUDED FROM SALE IN OR OUTSIDE OF THE MARKET

ANIMALS (WE AREN'T ACCEPTING MORE ANIMAL VENDORS)

FIREARMS (WITHOUT THE PROPER ATF LICENSE)

FIREWORKS

PORNOGRAPHY

DRINKS (WITHOUT BEING A FOOD CONCESSION)

DRUGS OR DRUG PARAPHERNALIA.

THE MARKET RESERVES THE RIGHT TO REFUSE TO RENT SPACE OR EXCLUDE SALES OF ANY ITEM OR VENDOR FROM SELLING AT THE MARKET FOR ANY REASON.

OUTDOOR MARKET IS INTENDED FOR GARAGE SALE TYPE ITEMS, SWAP MEET ITEMS OR HAND CRAFTED ITEM.
